- The 2008 and 2011 Teaching, Research, and International Policy (TRIP) Survey of International Relations Faculty lists twenty-five scholars "who have produced the most interesting scholarship in the past five years." (http://irtheoryandpractice.wm.edu/projects/trip). Erik Gartzke is listed in the 2008 report (tie for 23<sup>rd</sup>) and in 2011 (US results only, 20<sup>th</sup>). As the study notes, "very few scholars under the age of 50 rank amongst the most influential."
- A 2006 report by *Thompson Essential Science Indicators* examines author productivity in the areas of "war," "civil conflict," "insurgency," "political change," "international peace" or "armed conflict," based on a sample of 5,258 publications in 403 journals over the decade from 1996 to 2006. Erik Gartzke is listed as the 9<sup>th</sup> most productive researcher and ranked 15<sup>th</sup> in citations per article and 16<sup>th</sup> in total citations per author out of 5,311 authors from 1,507 institutions in 73 countries (http://www.esi-topics.com/armed-conflict/index.html).
